

City of Richmond Permit Fee Schedule

Surcharge change to \$5.00 for flat fee permits effective July 1, 2010 through June 30, 2011.

Building Permits - Residential

Residential	Valuation based using 1994 UBC Table 1-A
Plan Review	65% of Permit Fee
State surcharge	The greater of .0005 x valuation or \$0.50

Residential Building Permits - Maintenance

Roofing	\$ 35.75 + \$5.00 state surcharge = \$40.75
Siding	\$ 35.75 + \$5.00 state surcharge = \$40.75
Window/Door Replacement - Same Size	\$ 35.75 + \$5.00 state surcharge = \$40.75
Window/Door Replacement - Different Size	Valuation based using 1994 UBC Table 1-A
Demolition (Asbestos Inspection and Lab Fees not included)	\$ 35.75 + \$5.00 state surcharge = \$40.75
Fences over 6 feet	Valuation based using 1994 UBC Table 1-A
Pools - Permanent above and inground	Valuation based using 1994 UBC Table 1-A
Pools - Above ground less than 5,000 gallons	\$ 35.75 + \$5.00 state surcharge = \$40.75

Residential Mechanical Permits

Residential Alteration	\$ 35.75 + \$5.00 state surcharge = \$40.75
Residential Fireplace	\$ 35.75 + \$5.00 state surcharge = \$40.75
Residential New	\$ 35.75 + \$5.00 state surcharge = \$40.75

Residential Plumbing Permits

Permit Fee	The greater of 1% of the Project Valuation or \$36.25
Plan Review Fee	65% of the Permit Fee
State Surcharge	The greater of .0005 x valuation or \$0.50

Commercial Plumbing Permits

Permit Fee	The greater of 1% of the Project Valuation or \$36.25
Plan Review Fee	65% of the Permit Fee
State Surcharge	The greater of .0005 x valuation or \$0.50

Inspections Outside Normal Business Hours

\$60.00 per hour - 1 hour minimum

Inspections for which no fee is specifically indicated

\$30.00 per inspection

Investigation Fee

Work which was started without a permit shall be subject to an investigation fee equal to the permit fee less the surcharge.
